

Dollar Energy Fund– Dormont Appliance Gift Card Raffle
Contest Rules

1. HOW TO ENTER

Dollar Energy Fund– Dormont Appliance Gift Card Raffle entries will be available for purchase at the Dollar Energy Fund booth at the 2018 Home & Garden Show (David L. Lawrence Convention center - 1000 Fort Duquesne Blvd, Pittsburgh, PA 15222) Friday, March 2, 2018 through Sunday March 11, 2018. Times and locations are subject to change. Raffle entries will be sold for \$5 each. Participants must fill out the entry form and complete payment for their ticket entry for a chance to win. There is no limit to the number of ticket entries an individual may purchase. *The drawing will be held on Monday, March 12, 2018.*

2. ODDS: The odds of being selected as an official winner(s) are dependent upon the number of entries received.

3. ELIGIBILITY

The winner must be 18 years of age or older and a resident of the United States in a locale whose laws do not specifically prohibit such raffles. Employees of Dollar Energy Fund, Inc., the Duquesne Light Company, and any immediate family members residing with the employee are not eligible to participate. Only one (1) winner per household is permitted in any raffle.

4. PRIZES: No prize substitutions are allowed. Any applicable warranties will be provided by the donor or the manufacturer.
