DOLLAR ENERGY FUND, INC.'S UTILITY ASSISTANCE PROGRAM PROVIDES UTILITY ASSISTANCE GRANTS IN THE EXACT AMOUNT NEEDED TO RESTORE SERVICE OR PREVENT TERMINATION OF SERVICE AND IS APPLIED DIRECTLY TO A CUSTOMER'S ACCOUNT.
